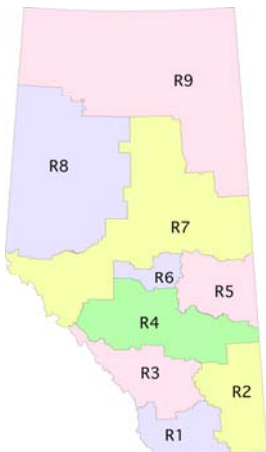

Alberta Blood Borne Pathogens and Sexually Transmitted Infections Action Plan

On April 16, 2008, the Alberta government announced the Health Action Plan to improve accessibility to health care and to ensure sustainability of the health system. Implementation of a Blood Borne Pathogens (BBP) and Sexually Transmitted Infections (STI) Strategy was identified as a three-month action item.

Why the need for a Blood Borne Pathogens and Sexually Transmitted Infections Action Plan?

Alberta has the highest rates of gonorrhoea, chlamydia and syphilis in Canada. This epidemic has reached a critical state – babies are dying from syphilis.

The rates of gonorrhoea, chlamydia and syphilis are rising at a rate greater than the national rate. STI rates have more than doubled over eight years. STI increases the risk of transmitting and acquiring HIV. Efforts to prevent STI also prevent HIV. In 2007, there were 225 cases of HIV as compared to 176 in 1999.

In March, 2007 the Acting Chief Medical Officer of Health declared a syphilis outbreak in Alberta. Since 2005, Alberta has seen 14 cases of babies with syphilis. To date, five babies have died and nine others will require long term follow up and assistance for those most severely affected. There had been no cases of syphilis in babies between 1992 and 2002 in the province.

Prior to 2000, Alberta had not had any locally acquired cases of syphilis for several years. In 2007, we had approximately 250 cases of syphilis reported.

BBP and STI are major causes of acute illness, long-term disability, infertility, cervical cancer, and even death. All of these diseases result in considerable health, social, emotional and economic costs, many of which are yet to be experienced. Given the grave and life-threatening significance of these diseases Alberta Health and Wellness must provide leadership to effectively prevent and manage BBP and STI in Alberta. Action is required that enables all Albertans access to the prevention and management of infections caused by BBP and STI.

A comprehensive BBP/STI Action Plan is necessary. Education is key. Public awareness of the risks and health consequences of BBP and STI are lacking. There appears to be a growing sense of security and unfounded optimism in the community, particularly among youth, about treatments and cures contributing to complacency and overall increased levels of unsafe sexual behaviour.

This Action Plan is aligned with other provincial efforts to reduce blood borne pathogens such as HIV and hepatitis C, support harm reduction activities, increase the healthy decision making behaviours of students, enhance Aboriginal people's health and promote overall youth and community wellness.

The attached table outlines Alberta Health and Wellness initiatives to decrease rates of BBP and STI in the province.
