Knowledge Transfer: Raising the Stakes for System Change

Knowledge transfer – moving knowledge into practice. Evidence-informed decision making. Sounds reasonable and

simple enough. Yet policies and practices in the health system often lag well behind discovery, or do not take evidence into account in decision making. The vision of the Health Research Transfer Network of Alberta (RTNA) is a health system where research or knowledge transfer (KT) is understood, valued, and optimized, where all stakeholders are supported and encouraged to express their will and desire to incorporate evidence into policy and practice decisions.

To realize this vision, the RTNA supports a culture of participation, networking, open dialogue and mentorship. This culture creates an expectation and support for the use of evidence while acknowledging the complexity of decisions. The RTNA 2007 conference is one way to help encourage and build that culture.

At this event, participants will learn about knowledge transfer from the outstanding speakers and from each other. We will explore the many challenges, innovations, processes, and practices that support and promote evidence-informed decision making at the individual decision maker, team, and system level.

We have chosen a theme and an image for the conference that plays off our venue and reminds us that KT is about increasing the odds for evidence-informed decision making. It also reminds us that the system needs to change if we are to fully realize the benefits of knowledge transfer and evidence-informed decision making. The opportunities the conference offers to gain knowledge, make new contacts, and learn new skills will help to "take the chance out of KT."


