Appointment of Dr. Sandy McEwan as Special **Advisor to Minister of Health on Medical** Isotopes

Dr. Alexander (Sandy) McEwan was appointed as special advisor on medical isotopes to the minister of health for the duration of the isotope shortage. Dr. McEwan is a member of Health Canada's Ad Hoc Group of Experts on Medical Isotopes and has been since the group was struck in 2007. He is past president of the Society of Nuclear Medicine and has been involved at the highest levels of the Canadian Society of Nuclear Medicine. Dr. McEwan is also a member of Health Canada's Regulatory Working Group on Medical Isotopes.

Dr. McEwan's work as special advisor on medical isotopes will include providing on-the-ground updates on the situation and how it is affecting patients; advising on how Health Canada can best support provinces, territories and the medical community in the use of alternatives and mitigation strategies; and supporting the minister in communicating the impact of the current shortage. These duties will supplement the work of the Ad Hoc Group of Medical Experts, which will continue to inform government actions on this file.

Dr. McEwan is currently chair of the Department of Oncology within the Faculty of Medicine and Dentistry at the University of Alberta, where he has been a faculty member since 1986. He is also adjunct professor of the Department of Radiology and Diagnostic Imaging within this faculty. In addition, he is the associate director of Research and the acting director of the

Department of Oncologic Imaging at the Cross Cancer Institute in Edmonton, Alberta.

Dr. McEwan has been instrumental in the development of the Positron Emission Tomography Program at the Cross Cancer Institute. He is a member of the Canadian Association of Nuclear Medicine, the Society of Nuclear Medicine, the European Association of Nuclear Medicine and the World Radiopharmaceutical Therapy Council. He is also past president of the board of directors for the Society of Nuclear Medicine.

Antoniou will report to Dr. Arthur T. Porter and be a member of MUHC's



Veteran Surgeon-Medical Director Receives Provincial and National Recognition



Dr. Mahmood A. Nagvi, MBBS, FRCS(c), FACS, DHA, medical director for the Cape Breton District Health Authority in Nova Scotia, has received the Order of Nova Scotia and will soon receive the Order of Canada. Recognition for Dr. Nagvi is based on his work over the past four decades to improve the delivery of healthcare to the people of

Cape Breton Island. Since the establishment of his first practice in New Waterford, NS, in the early 1960s, Dr. Nagvi has been a tireless contributor to the local, provincial and national healthcare sectors. From his early days of treating injured coal miners and of surgical accomplishments, to his instrumental role in the opening of the nationally recognized Cape Breton Cancer Centre, his common touch and wise guidance are highly respected. With the support of his fellow physicians and nursing colleagues, he helped to develop the area's first intensive care unit. Dr. Nagvi was also instrumental in consolidating the services of Sydney City and St. Rita's hospitals and supported the construction of the Cape Breton Regional Hospital and the creation of the Cape Breton Healthcare Complex. Today, he continues to guide the overall delivery of numerous clinical and medical aspects of the Cape Breton District Health Authority. While recognized as a skilled surgeon and administrator, he is also well known and respected as one of the provinces top physician recruiters and has helped to enhance the complement of family physicians and specialists in the district.

Honorary Graduate



Professor Denis Protti, FACMI, has received an honorary doctor of science degree from City University, London, England, Protti is professor of health informatics at the University of Victoria, Victoria, British Columbia, and is currently visiting chair of health informatics at City University. He was the founding director of the University of

Victoria's School of Health Information Science in 1981, a position

he relinquished in 1994. Prior to joining the university, Professor Protti held senior information systems executive positions in Manitoba and British Columbia hospitals. He was commissioned by the Her Majesty's Treasury to review the proposed 1998 National Health Service (NHS) Information Strategy for England prior to its release, and later developed the evaluation methodology that was used to monitor the local implementation of the national strategy – a process referred to as the Protti scores.

Professor Protti was a founding member of COACH - Canada's Health Informatics Association – as well as the American Medical Informatics Association. In 1989, he was one of the first non-Americans elected a fellow of the American College of Medical Informatics. He has chaired and served on numerous international, federal and provincial committees and councils over the past 40-plus years. Professor Protti has received a number of awards, including the COACH leadership award and the new Canadian Health Leadership Network's MacNaught-Taillon Award. He has also written numerous publications in books and journals as well as given presentations to a wide range of audiences around the world. His research and areas of expertise include national health information management and technology strategies, electronic health records, primary care computing and evaluating clinical information systems.

CHA 2009 Leadership Awards Conferred during National Healthcare Leadership Conference

The Canadian Healthcare Association (CHA) announced the recipients of two national awards recognizing outstanding contributions to the Canadian health system. Murray Ramsden of British Columbia is the recipient of the 2009 CHA Award for Distinguished Service, and Rosemarie Goodyear, of Newfoundland and Labrador, is the recipient of the 2009 Marion Stephenson Award for Outstanding Contribution to Community Care.



Murray Ramsden assumed the position of chief executive officer (CEO) upon the creation of the Interior Health Region, British Columbia, on December 12, 2001. He brought a wealth of experience in health administration to the position, including five years as CEO of the Okanagan Similkameen Health Region and five years as the chief operating officer of Kelowna General Hospital. He

also acted as the public administrator, appointed by the hinister of health, for three intermediate-care facilities, prior to their amalgamation with the Regional Health Board. Ramsden is an executive member of the Canadian College of Health Service Executives, a member of the Health Care Leaders' Association of British Columbia, a past director of the Canadian Association for Community Care, a director of the Canadian Council on Health Services Accreditation and a past director of the Canadian Health

Network; he also has membership on several provincial health committees and continues his involvement in many community services.



Rosemarie Goodyear is known in Newfoundland and Labrador as a strong advocate for the community sector and is frequently asked to participate on provincial committees due to her expertise and hard work. Goodyear is dedicated to quality health outcomes that are grounded in heath promotion and prevention, and span the continuum from community-based to specialized institutional healthcare. Since 2005,

Goodyear has worked as the vice-president for community health and primary health care with Central Health in Newfoundland and Labrador. Prior to that, she was the assistant CEO and chief nursing officer with the legacy community health board in that region. These roles exemplify her tireless commitment throughout her career for the overall development of the community sector. Goodyear is an accomplished administrator, researcher and author. Her many professional activities promote the nursing profession and contribute to the optimal health of the citizens of Newfoundland and Labrador.

Recent Awards from Canadian Medical Association

A physician whose donations led to the establishment of the Northern Health Sciences Centre at the University of British Columbia (UBC) and a Montreal scientist whose research involving human immunodeficiency virus (HIV)/acquired immunodeficiency syndrome (AIDS) is recognized around the world were among 11 people honoured by CMA during its annual awards ceremony in August. The presentations were made before a large crowd, following the CMA's 142nd annual meeting in Saskatoon, Saskatchewan.

Dr. Donald Rix of Vancouver, British Columbia, received the F.N.G. Starr Award for "outstanding achievements in advancing the cultural life of his community and improving medical service in Canada." It is the highest award CMA can bestow upon a member. In addition to funding the centre at UBC, he created

a permanent endowment fund to provide bursaries for medical students and a permanent benevolent fund to help physicians and their families who experience financial difficulties due to illness.

Dr. Michel Bergeron, a professor and chair of microbiology at Université Laval, was awarded the CMA Medal of Service



for making "an exceptional and outstanding contribution to the advancement of healthcare in Canada." His work includes the development of rapid deoxyribonucleic acid (DNA)-based tests.



Mark Wainberg, PhD, received the CMA Medal of Honour for his many achievements in the field of HIV/AIDS-related research, including the initial identification of 3TC as an anti-viral drug. The medal is "the highest award the association can bestow on a person who is not a member of the medical profession."



The CMA May Cohen Award for Women Mentors was presented to Dr. Catharine Whiteside, dean of medicine at the University of Toronto, Toronto, Ontario. The citation states that she "directly and indirectly influenced many women within the medical community and has taught them to be reflective, to express their views and to network."



The CMA Sir Charles Tupper Award for Political Action was awarded to Dr. Marilyn Trenholme Counsell in recognition of "exemplary leadership, commitment and dedication to the advancement of goals of the CMA in the political arena." She is a former member of the New Brunswick legislature and recently retired from the Canadian Senate.



The CMA Dr. William Marsden Award in Medical Ethics was presented to Dr. Nuala Kenny, founding chair of the Department of Bioethics at Dalhousie University, Halifax, Nova Scotia. It recognizes her work as an "advocate, model and teacher for ethical reflection in medical, community and political life across Canada."

The Elementary Teachers' Federation of Ontario is recipient of the CMA Award for Excellence in Health Promotion in recognition of its work to help young students develop healthy self-esteem and body image via an evidence-based program, Reflections of Me: Body Image and Self-Esteem.



A physician, resident and two medical students received CMA Awards for Young Leaders. In the student category, Juliet Emamaullee, PhD, of

the University of Alberta. Edmonton. Alberta, was honoured for her leadership



achievements, which included co-founding a women's surgery interest group. She was joined by Charlotte Kfoury of McGill University, Montreal, Quebec, who is a

founding member of the Health Squad Project, which involves outreach by medical students throughout Montreal.



In the resident category, Dr. Devesh Varma was honoured for his work with the Canadian Association of Interns and Residents. As president, he spearheaded a major governance review of the organization.



The final award, for exemplary leadership by an early-career physician, was presented to Dr. Jordan Cohen, director of student affairs at the University of Calgary, Calgary, Alberta. He was honoured for "dedication to making a difference in physician health and wellbeing that has benefited the medical community across Canada."

Winners of 2009 Robert Wood Johnson Award

Susan Delaney, Johanna Arnett, Sonia Sizto, Olivier Demers-Payette, Jennifer C. Hunt and Liane Fernandes are this year's recipients of the Robert Wood Johnson Award. The Robert Wood Johnson Award, established in 1956 by Johnson & Johnson, is exclusively for students. It is presented to one student from each of the six Canadian universities offering graduate programs in health services administration. Those universities represented are the University of British Columbia, University of Alberta, University of Toronto, University of Ottawa, University of Montreal and Dalhousie University. Each of the six faculties will choose a student viewed as the most likely to contribute valuable service to health services management. The award consists of \$2,000, a Certificate of Merit, travel and accommodation expenses to attend the awards ceremony.

The first presentation of the Robert Wood Johnson Award was made to the University of Toronto in 1956. To date, 230 individuals have received the award. A few notable recipients include: Devidas Menon, professor of Health Policy and Management at the University of Alberta; Tony Dagnone, Fellow of the American College of Healthcare Executives and recipient of the College's Chair's Award for Distinguished Service; Kenneth J. Fyke, author of the report: Caring for medicare: Sustaining a Quality System, David Levine, Policy Administrator and former CEO of the Ottawa Hospital.
